#### BRIEF INFORMATION ABOUT THE PRODUCT

##### 1. What is this product about?

The Fund aims to achieve long-term capital growth through diversified investments in equities and bonds.

#### PRODUCT SUITABILITY

##### 2. Who is this product suitable for?

The Fund is suitable for investors who are seeking a combination of both capital appreciation with income distribution, have moderate risk tolerance and can withstand short-term volatility, and have long-term investment horizon.

#### KEY PRODUCT FEATURES

##### 3. What am I investing in?

<b>Fund Type</b>	Income & growth
<b>Fund Category</b>	Balanced
<b>Launch Date</b>	23 April 2004
<b>Investment Strategy</b>	The Fund invests in a mixture of equities, bonds and money market instruments. The Fund engages active tactical allocation between asset classes with emphasis on managed growth and selects securities based on current earnings, growth prospects and potential for capital appreciation as well as income distribution. Tactical asset allocation between assets and sectors is determined by analyzing the economy, which influences the business cycle, and market factors.
<b>Asset Allocation</b>	Equities : 40% to 60% of the Fund's NAV Bonds/ Liquid assets : 40% to 60% of the Fund's NAV

##### 5. What are the possible outcomes of my investment

Unit prices for this Fund may go down as well as up. The Fund is exposed to a variety of risks by nature of the investment strategy of the Fund. As such, the Fund does not provide guarantee on the investment amount nor does it guarantee a fixed rate of return.

#### KEY RISKS

##### 6. What are the key risks associated with this product?

Investors are advised to read the Fund's prospectus and understand the risks involved and if necessary, consult a professional adviser for a better understanding of the risks before investing.

##### General Risk related to the Fund

<b>Market Risk</b>	Market risk refers to the possibility that an investment will lose value because of a general decline in financial markets, due to economic, political and/or other factors, which will result in a decline in the fund's net asset value.
<b>Manager's Risk</b>	This risk refers to the day-to-day management of the fund by the manager which will impact the performance of the fund. For example, investment decisions undertaken by the manager, as a result of an incorrect view of the market or any non-compliance with internal policies, investment mandate, the deed, relevant law or guidelines due to factors such as human error or weaknesses in operational process and systems, may adversely affect the performance of the fund.
<b>Liquidity Risk</b>	Liquidity risk refers to the ease of liquidating an asset depending on the asset's volume traded in the market. If a fund holds assets that are illiquid, or are difficult to dispose of, the value of the fund will be negatively

	affected when it has to sell such assets at unfavourable prices.
<b>Inflation Risk</b>	This is the risk that investors' investment in the fund may not grow or generate income at a rate that keeps pace with inflation. This would reduce investors' purchasing power even though the value of the investment in monetary terms has increased.
<b>Non-Compliance Risk</b>	This refers to the current and prospective risk to the unit trust fund and the investors' interest arising from non-compliance of regulations imposed by the Capital Markets and Services Act 2007 and the guidelines, deeds, prospectuses and/or manager's internal policies and procedures by the manager. Risk of non-compliance can lead to diminished reputation, reduced franchise value, limited business opportunities and reduced expansion potential for the company. Accordingly, non-compliance may affect the investor's investments by causing a fall in the value of the unit trust fund.
<b>Loan Financing Risk</b>	This risk occurs when investors take a loan/financing to finance their investment. The inherent risk of investing with borrowed money includes investors being unable to service the loan repayments. In the event units are used as collateral, an investor may be required to top-up the investors' existing instalment if the prices of units fall below a certain level due to market conditions. Failing which, the units may be sold at a lower net asset value per unit as compared to the net asset value per unit at the point of purchase towards settling the loan.

#### Specific Risks related to the Fund

<b>Interest Rate Risk</b>	Interest rate risk refers to the impact of interest rate changes on the valuation of a bond/sukuk or money market instruments/ Islamic money market instruments (hereinafter referred as "investment") portfolio. When interest rates rise, the investment prices will generally decline and this may lower the market value of the investment portfolio. The reverse may apply when interest rates fall. The risk will be mitigated via the management of the duration structure of the investment..
<b>Credit and Default Risk</b>	Credit risk relates to the creditworthiness of the issuers of the fixed income securities/sukuk or money market instruments/ Islamic money market instruments (hereinafter referred as "investment") and their expected ability to make timely payment of interest/profit and/or principal. Any adverse situations faced by the issuer may impact the value as well as liquidity of the investment. In the case of rated investment, this may lead to a credit downgrade. Default risk relates to the risk that an issuer of the investment either defaulting on payments or failing to make payments in a timely manner which will in turn adversely affect the value of the investment. This could adversely affect the value of the Fund.
<b>Reinvestment Risk</b>	Reinvestment risk arises when an issuer of bonds decides to exercise its right to pay principal on an obligation earlier than the expected maturity date, especially during times of declining interest rates. Consequently, the Fund may experience lower returns due to having to reinvest in lower yielding securities.
<b>Counterparty Risk</b>	Counterparty risk occurs when a financial institution that has entered into a securities trade defaults on its obligations under the agreement. The Fund may encounter Unit price volatility due to this risk arising.
<b>Stock Specific Risk</b>	Prices of a particular Shariah-compliant stock/ stock may fluctuate in response to the circumstances affecting individual companies such as adverse financial performance, news of a possible merger or loss of key personnel of a company. Any adverse price movements of such stock will adversely affect the Fund's net asset value.
<b>Derivatives Risk</b>	The Fund may from time to time use derivatives for hedging. Derivatives are financial contracts whose value depend on, or are derived from, the value of an underlying asset, reference rate or index. Such assets may include shares, interest rates, currency exchange rates and stock indices. The use of derivatives may result in a lower NAV price. Some of the risks associated with derivatives are market risk, management risk, credit risk, liquidity risk and counterparty risk. While the hedging strategy will assist in mitigating the potential losses by the Fund, any potential gains from the hedging strategy will be capped as well.

### 9. How do I exit from this investment and what are the risks and costs involved

Unit Holders may redeem their investments in the Fund on any Business Day by completing the prescribed redemption request form or such other manner as the Manager may accept and returning it to the Manager on any Business Day; the redemption request form is available at the office of the Manager.

Units redeemed during dealing hours (i.e. from 8.30 a.m. to 4.00 p.m.) on any Business Day will be redeemed at the NAV per Unit calculated as at the next valuation point after the request is received (i.e. "forward pricing").

Any redemption request received after the dealing hours on any Business Day will be taken as a redemption request made on the next Business Day.

The minimum redemption amount is 500 Units for each transaction or such other lower amount as the Manager in its sole discretion allows.

However, if the redemption request leaves a Unit Holder with less than 500 Units (minimum holdings), the Manager reserves the right to liquidate the balance of the Units held in the Unit Holder's account.

Redemption proceeds will be paid within ten (10) days from the date the Manager receives a duly completed redemption request form.

#### **Cooling-Off Right**

A cooling-off right is only given to an individual investor who is investing for the first time in any unit trust funds managed by the Manager but shall not include the Manager's staff and a person registered with a body approved by the Securities Commission Malaysia ("SC") to deal in unit trusts.

The cooling-off period shall be within six (6) Business Days from the date the Manager receives the duly completed form. "Cooling-Off Period" or Cooling-Off Right" is not applicable to EPF Member Investment Scheme.

We take into account and factor in all the distributions and unit splits into the NAV of the Fund for the purposes of the calculations.

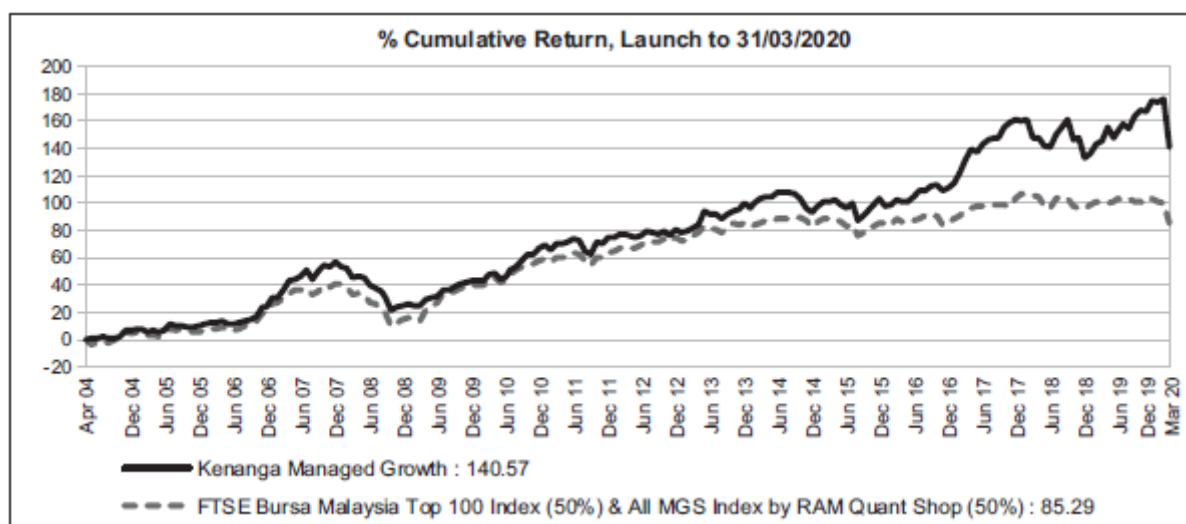

### 1-Year Fund Performance Review

The Fund recorded a negative return of 2.11%, underperforming the benchmark negative return of 7.10%. The Fund's underperformance as compared to the benchmark was attributed to the fund's holding in small cap stocks which corrected sharply during the March 2020 market turmoil as well as corporate bonds which underperformed the strong rally in government bonds.

#### Explanation of significant change in the PTR

PTR is relatively stable compared to the previous year due to similar portfolio rebalancing activities for both equity and fixed income securities.

#### Explanation of significant change in the MER

MER ratio of 1.85% indicates an expense of RM0.0185 for every RM1.00 of the average NAV of KMGF during the financial year ended 31 March 2020. MER is lower against previous financial year mainly due to higher average fund size during the financial year under review.

<b>Business Day</b>	Means a day on which the Bursa Malaysia is open for trading.
<b>long-term</b>	Refers to a period of more than five (5) years.
<b>Management Expense Ratio (MER)</b>	$\frac{\text{Total annual expenses incurred by the Fund}}{\text{Average NAV of the Fund calculated on daily basis}} \times 100$ <p>This ratio will inform you of the total expenses incurred by the Fund during the year as compared to its average NAV. Total expenses include management fee, trustee fee and expenses incurred for fund administrative services. A low MER indicates the effectiveness of the Manager in managing the expenses of the Fund.</p>
<b>MGS</b>	Malaysian Government Securities.
<b>Net Asset Value (NAV)</b>	Means the total value of the Fund's assets minus its liabilities at the valuation point. In computing the annual management fee and annual trustee fee, the NAV of the Fund should include the management fee and the trustee fee for the relevant day.
<b>NAV per Unit</b>	Means the NAV of the Fund divided by its total number of units in circulation.
<b>Portfolio Turnover Ratio (PTR)</b>	<p>Refers to the measure of trading activity or how frequently assets within a fund are bought and sold by the Manager. A fund with a 0.5 times portfolio turnover ratio, for example, replaces half of its holdings during the period under review.
